5. Do the teachers have any say in this ?

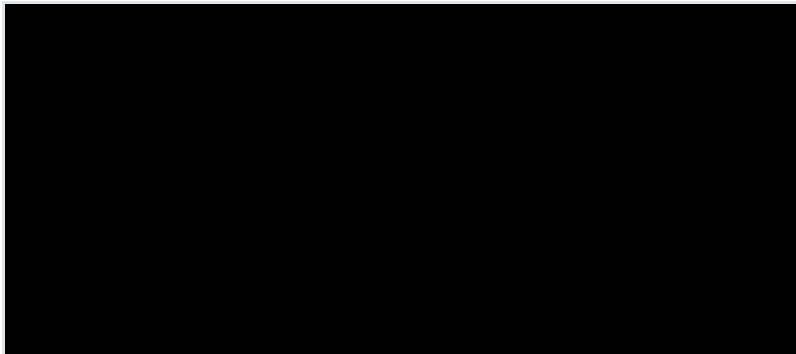
I hope to see your answers or we can go over it at the first school Bd meet
