Action Plan in Response to the Poll Book Error of November 2025

This Action Plan was developed in response to the findings and recommendations of the independent investigation into the error that resulted in third-party registered voters being omitted from poll books on November 4, 2025. Affected voters included those registered as Independent, Libertarian, "No Affiliation," or "Non-Partisan." As a result, more than 12,000 provisional ballots were cast in Chester County on Election Day, the majority resulting from this error.

The law firm Fleck Eckert Klein McGarry, LLC (FEKM)¹ conducted a comprehensive review of the incident to determine the root cause and provide actionable recommendations. Additionally, the County's Chief Experience Officer (CXO) conducted Election Day debriefs and met individually with Voter Services staff. The table below summarizes the actions the County will take to improve oversight and accountability, and prevent reoccurrence.

3.1	FEKM recommends formal documentation of the Voter Registration Commission and the delegation of duties under its jurisdiction.	Open	County will further examine this recommendation in the context of existing structures, procedures, and staffing.
3.2	FEKM recommends the development of standardized training for all new hires and cross-training for existing staff in Voter Services.	Open	County concurs and plans to proceed accordingly.
3.3	FEKM recommends evaluation of staffing levels and compensation structures in Voter Services relative to surrounding counties.	Open	County concurs and also plans to initiate a comprehensive review of all HR policies in Voter Services.
