Resolution No. 7 of 1996

A RESOLUTION DESIGNATING 1921.96 ACRES OF LAND SITUATED IN WILLISTOWN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, AS AN AGRICULTURAL SECURITY AREA PURSUANT TO THE TERMS AND PROVISIONS OF ACT 43 OF 1981 AS AMENDED.

WHEREAS, on August 9, 1988, the Willistown Township Board of Supervisors adopted Resolution No. 18 of 1988 designating 1759.3 acres of land owned by 27 different landowners in Willistown Township as an Agricultural Security Area, pursuant to Act 43 of 1981; and

WHEREAS, subsequent to the passage of Resolution #18 of 1988, two residents decided that they did not wish to be included in the Area; and

WHEREAS, Resolution No. 17 of 1989 was passed which amended Resolution No. 18 of 1988 by reducing the acreage represented by these two properties; and

WHEREAS, the amended acreage recorded after the passage of Resolution No. 17, of 1989 designated 1711.3 acres by 25 landowners as the Agricultural Security Area; and

WHEREAS, Act 43 requires that the governing body shall review any Area created under section eight of the Act seven years after the date of creation and every seven years thereafter; and


WHEREAS, The Act describes the procedure to be taken pursuant to the review of the Area; and

WHEREAS, Willistown Township has followed the procedure for review and re-adoption of the Area and it is the decision of the Board of Supervisors that it is in the best interest of Willistown Township and its residents to re-adopt the revised Agricultural Security Area consisting of 1921.96 acres owned by 30 landowners;

NOW, THEREFORE, BE IT RESOLVED that the Willistown Township Board of Supervisors adopts the revised Agricultural Security Area and directs that the Area, a list of its acreage and individual owners be recorded with the Recorder of Deeds of Chester County.

ADOPTED this 27rd day of February, 1996.
